Rent Review & Lease Renewal

Modern leases of any length provide for regular rent reviews. The lease will set out the basis of review, usually to Open Market Rental Value. It is important that landlords and tenants seek advice at an early stage to ensure that effective action is taken.

For a landlord, this is an opportunity to maximise return and increase capital value while a tenant must be careful to minimise cost to their business. It is important for both parties to be professionally advised.

In the main, commercial tenants have the right of lease renewal under the Landlord

and Tenant Act 1954 subject to the landlord's right to oppose a renewal on the grounds of substantial breach of the lease, redevelopment and occupation by the freeholder. Well in advance of lease renewal, the landlord should consider when to trigger a lease renewal through a Section 25 notice and tenants should consider their options by taking advice about a Section 26 notice.

With a fully analytical approach to assess lease terms, the features of the property and market comparisons, our surveyors are best placed to ensure that rent and lease terms are agreed to the best advantage of our clients. Where a negotiated settlement is not possible, they have the grounding to prepare submissions to arbitrator or independent expert in rent review and to Court or PACT (Professional Arbitration on Court Terms) for lease renewal.
